Course Syllabus

Course Title: Facility Fire Brigade Leader

Course Duration: 16 hours

Program: Industry

Course Prerequisites: Facility Fire Brigade Advanced Exterior or Interior Structural

Course Description: This 16-hour course is designed for facility fire brigade members that are, or are preparing to be, in a leadership role. Students will gain experience managing different types of emergency incidents that they could face at their facility. They will also be instructed on the importance of, and methods of managing, the health and safety of their brigade members. Upon successful completion of this course they will receive a ProBoard certificate.

Course Requirements:

Pre-Course Work – None Course Work – Complete all classroom, homework, and drills. Post-Course Work – None

Course Policies:

Safety Policy: Students shall understand and follow all instructions pertaining to operational safety, as stated by instructors or as written in course materials. Instructors and students shall be mindful of safety at all times. Conduct judged to be unsafe shall be grounds for dismissal from the course.
