Course Title: Hazardous Materials Technician: Decontamination Refresher

Course Duration: 8 Hours

Program: Special Operations Training Program

Course Prerequisites: Hazardous Materials Technician

Course Description: Special Operations Training Program Refresher Courses provide hands on training at the technician level. Participants will have the opportunity to refresh critical skills through classroom review, drills and/or scenario exercises. This course covers a review of standard formal decontamination techniques, dry decon, and radiological decon.

Course Requirements and/or Recommendations: These can be divided into three categories: those completed prior to arriving in class (Pre-Course Work), those completed during class, such as homework assignments and quizzes (Course Work), and requirements completed after class but prior to receiving a certificate of completion. (Post-Course Work)

- 3. Demonstrate the proper selection, set-up, operation, and tear down of a decontamination line.
- 4. Identify the equipment needed for dry decontamination.
- 5. Establish a dry decontamination corridor.
- 6. Perform dry decontamination as a Decon team member or an Entry team member.
- 7. Identify the equipment needed for radiological decontamination.
- 8. Establish a radiological decontamination corridor.
- 9. Perform radiological decontamination as a Decon team member.
